

## 2020 MEMBERSHIP FEE SCHEDULE

### Regular Membership

Applies to non-profit housing providers that manage/own housing in the affordable housing sector. Includes: voting capacity at AGM, and any other general and special meetings, ability to sit on Board and all member benefits.

All Organizations	Cost
Flat rate up to 50 Units	\$300
More than 50 units to 1000	\$6.00/unit
Units above 1000	\$1.00/unit

Examples:

38 units	376 units	1241 units
	376 @ \$6.00/unit	1000 @ \$6.00/unit
		241 @ \$1.00/unit
<b>Total \$300</b>	<b>Total \$2256</b>	<b>\$6241</b>

### Associate Membership

Applies to Organizations that do not meet the criteria of Regular Membership and Government Agencies. This category does not have voting capacity but are eligible to other benefits.

Fee: \$300 -Organizations, \$500 Government Agencies,  
\$100- Individual membership

### Corporate Membership

Applies to businesses that offer products and services relevant to the sector. Includes company logo and write up on website and features in newsletter.

Fee: \$500- \$2000/annum

**2020 Corporate Fee Schedule**  
(For all new and renewing members)

**Level One: Corporate Member**

- \$500 Annually
- Logo on website as Corporate member
- For those businesses that are looking to sell a product or service, some sort of member enticement (“ANPHA members receive...”) will be required.
- Corporate membership will be required before submitting any joint or endorsed funding applications.

**Level Two: Corporate Member/Sponsor**

- \$2000 annually
  - \$500 base Membership
  - \$1500 lump sum paid at time of signing/renewal
- Logo on website as Corporate member
- Logo in Monthly newsletter as Corporate Sponsor <sup>1</sup>
- 2x annual feature in Newsletter
- Monthly social media feature
- No other funding/sponsorship will be requested
- \$1500 can also be paid via shared revenue agreements<sup>2</sup>

**Level Three: Corporate Member w/ Sponsorship Opportunities**

- \$500 annual base membership
- Logo on website as Corporate member
- Ongoing opportunity to sponsor events will be offered/solicited throughout year.
- Logo and “sponsored by” feature on event promotions
- If \$1500 in sponsorship is reached in calendar year<sup>3</sup> Option Two benefits take effect for remainder of term.
  - Logo in Monthly newsletter as Corporate Sponsor
  - 2x annual feature in Newsletter
  - Monthly social media feature

Additionally, Corporate Members may be invited to sponsor larger initiatives, where appropriate. Approval for these initiatives will be at the discretion of the Board.
